Booking Policy

- Members may book up to 3 separate tee times at any given time.
- Simulator access is subject to availability and peak-time limitations.
- Cancellations must be made at least 6 hours in advance.

No-Show Policy

If a member fails to cancel and does not show up for a booking:

- A No-Show Fee will be charged to the card on file.
- The fee is calculated as:

Hourly Simulator Rate × Number of Hours Booked

• The hourly simulator rate is defined as the public rate for that time slot.

Membership Freezes

Memberships can only be paused for verified injuries. No freezes for travel, weather, or scheduling conflicts.

Cancellation & Reinstatement Policy

- Cancel anytime by email, phone, or in person.
- If canceled, you have **3 days** to reinstate your membership without paying the membership fee again.
- After 3 days, rejoining will require a new membership fee.

By enrolling in the Golf Island Corporate Membership ("Membership"), the enrolling business ("Member Organization") agrees to the following terms and conditions:

1. Membership Structure

- This is a **seasonal, one-time payment corporate membership** for use of our indoor golf simulator facilities.
- Memberships are available in two terms:
 - o October 1st March 31st: \$6,000 pro-rated monthly
 - o **April 1st September 30th:** \$4,500 pro-rated monthly
- Memberships do not auto-renew. A new agreement and payment are required for each season.
- The organization may assign up to **10 employees** as authorized users. This list can be updated once per season.

2. Seasonal Benefits

Season	Simulator Hours/Day	Food, Drink, & Extras Discount
April – September	4 hours/day	25% off food, drink, additional simulator time, lessons, merchandise, and leagues
October – March	2 hours/day	20% off food, drink, additional simulator time, lessons, merchandise, and leagues

- Simulator hours are shared among all authorized users per day.
- Discounts apply to the authorized user and up to 3 accompanying guests per visit.

 Discounts are valid only during the membership period and cannot be combined with other promotions unless otherwise stated.

3. Payment Terms

- Full payment is due **upfront** at the time of registration for the selected season.
- Payment is **non-refundable** and non-transferable.
- A **valid business credit card** must be kept on file for incidentals (e.g., no-show fees).
- Payment methods include credit card, ACH, or check payable to "Golf Island".

4. No-Show Policy

- Bookings must be canceled at least 6 hours in advance.
- Failure to cancel will result in a **no-show fee**, charged to the card on file.
- No-Show Fee = Hourly Simulator Rate × Number of Hours Booked
- The **hourly simulator rate** is defined as the standard public rate for simulator rentals during the booked time slot.

5. Booking Limit

- Members may hold up to five (5) separate tee time reservations at any given time.
- Additional bookings will not be permitted until one or more of the existing reservations has been used or canceled.
- Members are encouraged to cancel reservations they cannot attend to allow access for others.
- These hours may be booked by any combination of authorized users.
- Unused daily hours do not roll over to future days.

6. Cancellation Policy (Membership)

- Members may cancel their membership at any time by providing notice:
 - By email
 - o In person
 - By phone
- Cancellations must be received at least 48 hours before the next billing cycle to avoid being charged for the upcoming month.
- If a membership is canceled, the member may **reinstate** the membership within **3 days** without incurring a new initiation fee. After 3 days, the **membership fee** will be required to reactivate the membership.
- No refunds or prorated credits will be issued for partial months or unused time.

7. Renewal

 Memberships do not auto-renew. A new agreement and payment are required for each season.

8. Freezing or Extending Membership

- Memberships cannot be frozen, extended, or prorated under normal circumstances.
- Exceptions may be considered for extended facility closures or documented emergencies, at the discretion of Golf Island.

9. Guest Policy

- Each authorized user may bring up to three (3) guests per visit.
- Guests must always be accompanied by a listed authorized user.
- Guests are eligible for applicable member discounts on food, drink, golf, lessons, and merchandise when visiting with an authorized user.
- The Member Organization is responsible for the conduct and any damages caused by its users and guests.

10. General Terms

- Memberships are valid only for authorized users designated by the organization and are **non-transferable**.
- Facility availability may vary due to maintenance, special events, or holidays.
- Misuse of the membership, violations of rules, or inappropriate conduct may result in suspension or cancellation of privileges without refund.
- The Member Organization assumes responsibility and risk for the use of the facility by its users and guests.

11. Sample Hourly Rate Table (For Example Purposes Only)

The following rate table is an example and does not reflect actual pricing. Hourly simulator rates vary based on season, time of day, and day of the week. Please refer to the official booking portal or contact staff for current pricing.

Time Slot	Hourly Rate Description	
Peak Hours	\$60/hr	Monday to Friday: 5:00 PM – 10:00 PM
Off-Peak Hours	\$40/hr	Monday to Friday: 9:00 AM – 4:00 PM
Weekend (Peak)	\$65/hr	Saturday & Sunday: 9:00 AM – 10:00 PM
Weekend (Off-Peak) \$45/hr		Saturday & Sunday: 9:00 AM – 4:00 PM

12. No-Show Fee

 No-show fee will be charged at the hourly rate for the reserved time slot multiplied by the number of hours booked. This is in accordance with the No-Show Policy.

13. Example Calculation of No-Show Fee

If a member books 2 hours during a **Peak Hour** time slot (e.g., 5:00 PM to 7:00 PM), and fails to cancel at least 6 hours in advance, the **no-show fee** would be:

Peak Hour Rate x 2 hours booked = \$60 x 2 = \$120
